A charitable gift annuity (CGA) is a contract between a donor and The Masonic Charity Foundation of Connecticut whereby, in exchange for an irrevocable gift of cash or securities, the annuitant (typically the donor) receives a fixed income for life at a highly competitive rate while simultaneously supporting the mission of Masonicare.



Annuities can be single-life or two-life contracts and income rates depend upon the age(s) of the annuitant(s) at the time the gift is made. Donors also enjoy the tax incentives associated with their CGAs. Not only can a donor claim a charitable deduction with their gift annuities, but a portion of the fixed income payments received is tax free as well.





(Note: if a CGA is funded with appreciated securities, capital gains taxes may be reduced).

Example:

Eleanor D., age 82, contributes \$20,000 in cash and receives a lifetime annuity of \$1,700, of which \$1,249.50 is tax-free for approximately the first eight years. As the annuitant, she receives an income tax deduction of \$9,631.60, resulting in tax savings when she claims it. At Eleanor's passing, the gift annuity remainder goes to The Masonic Charity Foundation of Connecticut.

"Ithink it's one of the better places to donate to," said Art, "because of what they provide in terms of care and what they do for the people that live at Masonicare."

Since its introduction to Freemasons and Masonicare Residents, the Charitable Gift Annuity program has become hugely popular throughout the community. Couple Art's affinity for Masonicare as a 50+ year Freemason with the enticing tax deduction benefit and strong interest rates (fixed based on a donor's age when the annuity is established), you can see why it's a popular giving vehicle.

"I've encouraged several of my friends and brethren to donate because of the financial benefits," said Art, "and of course to support the Foundation."

Art has seen Masonicare grow beyond his expectations. "I recall being a young Mason living in Manchester and hoping that the Masonic Home and Hospital (now Masonicare Healthcare Center) would be there, but boy has it expanded into what it is today."


